

APPLICATION AND AFFIDAVIT OF NONRESIDENCE AND MILITARY SERVICE EXEMPTION FROM MOTOR VEHICLE AD VALOREM TAX

Incomplete documentation will not be processed -

1. APPLICANT - This form is to be completed when the vehicle owner(s) meet the exemption requirements as the Servicemembers Civil Relief Act contained in 50 App. U.S.C.A. § 571. Only the military individual or a lawful agent with power of attorney (POA) may execute this affidavit. Registration must be completed within 60 days of affidavit execution. This form, its contents and attachment shall be considered confidential and shall not be available for release to the public except in accordance with applicable law. Laramie County reserves the right, and the applicant, or their agent, by signature below agrees, that Laramie County or its agents may conduct such investigations as necessary and request any documentation as needed in their discretion to confirm the assertions made by applicant in the execution of this form. This process may result in delay in the granting of the exemption requested herein. Joint or co-ownership of a motor vehicle by a resident and non-resident may bar the granting of an exemption. False or misleading information provided herein or attempts to improperly procure exemption will result in referral to State or Federal law enforcement as well as the applicant's chain of command and criminal prosecution may result from same.

- I am a named owner on the vehicle for which the exemption is being claimed.
- This vehicle will not be used in any trade or business in the State of Wyoming. Should this vehicle be used as part of a business, the vehicle will be subject to full payment of all taxes due.
- I have not registered to vote in the State of Wyoming, applied for a veterans exemption for ad valorem tax as a veteran pursuant to W.S. 39-13-105 or
- represented to any governmental or private entity that I am a resident of the State of Wyoming in order to procure any benefit
- Execution of this claim for exemption of specific ownership will require:
 - Servicemember - Military ID is required to be presented with this form and copy of orders and leave and earning statement showing residency is required to be attached to this form.
 - Servicemembers Spouse - Copy of orders and servicemembers leave and earning statement showing servicemembers residency and Power of Attorney is required to be attached to this form.
 - Such other documentation as may be required by the Laramie County Treasurer to confirm eligibility
